NOTES from the **President**

My second-to-the-last Chip Shots Note... not that I'm counting. One of the more unpleasant tasks I have as a board member, and President, is to approach members that are abusing the intent of our by-laws and policies. I try to be tactful in doing so, but this is not always easy. Case in point:

To give you the background, an item of discussion at the last several board meetings is the fact that we have some groups of players that are riding single in golf carts. We have posted notices of limits on the number of carts per group on the bulletin board, the pro shop and in the restrooms. Unfortunately, the current by-laws only cover the limits on groups up to 6-somes. Now it seems to me that the obvious intent is that riders should share carts, unless there is an odd number of players, but this apparently is not clear to some of our members. Our cart lease program, and cart rentals are for a rider, not a cart (i.e.: If you have a cart lease, you cannot rent a cart, and have a member or guest who is not a member of the cart lease program ride with you). But I digress.

I was finishing my rather pitiful round of golf Saturday, and noticed five carts lined up by the tenth tee, at least three of which had single riders. I approached one of the members in the group (who will remain unnamed), and quietly mentioned that this was inappropriate, and that they should pair up. He angrily retorted that this was "ok," that they were not hurting anything, and that "this is how it's been for 40 years." He then drove off in a huff, with what looked like a train behind him.

First, it is **not** ok. As we go to print, the board is redrafting the cart policy in light of the fact that we do allow 6-somes and even 8-somes play as long as they do not hold up play, and allow other groups waiting behind them to play through. Even though the current policies do not contemplate groups this large the intent is clear... it's sad that the board needs to re-draft the policies, and consider sanctions for their violation.

Secondly, the unnecessary use of more carts **does** hurt the club. The club pays for the electricity to charge the carts, and the maintenance to keep them in good running order. Batteries have to be replaced, and our staff has to bring them up and return them to the cart shed. Moreover, overuse of carts limit the ability of the club to extend their lease-life, which would save our club money. Finally, cart use damages our course. Our Superintendent, Danny would tell you that a significant part of our maintenance costs are due to cart usage. How many times do we see tire ruts in our fairways and rough?

Forty years? I don't think so. I've been a member for well more than 40 years, and do not recall this being a problem until recently. The fact is, we have only been allowing groups greater than 4-somes (with the exception of the Sunday morning gaggle), for the past 12 years.

It is unfair pressure on the club's staff to have to approach members on issues such as this one, which is why I spoke up in the first place.



MERCED GOLF & COUNTRY CLUB DRESS CODE

CLUBHOUSE & DINING ROOM

All members and guests are required to adhere to Merced Country Club's Dress Code when in the club. These general guidelines apply for adults and children above the age of five. The dress code is listed below:

Jackets maybe required for more formal events. Women are requested to dress in a fashion compatible with the dress required of men, which may include dresses, skirts, slacks or pantsuits.

Typical golf attire; and clean, comfortable attire are encouraged at all times. Ladies may wear sleeveless shirts that have a collar; or a non collared shirt with sleeves. Men's Golf attire, blue denim clothing and blue denim jeans in good, clean condition are acceptable attire in the Bar, Dining Room, Patio, Pool, Parking Lot, Pro Shop, Locker Rooms and Club Offices.

NO BLUE DENIM JEANS are allowed on the Golf Course, Putting Green, Driving Range, and Practice Facility.

The following attire is <u>NOT allowed</u> in the *Clubhouse* (Including the Dining Room, Bar and Banquet Room), on the *Golf Course* or *Driving Range*

- Shorts, skorts or skirts higher than 4" above the knee
- T-Shirts or Tank Tops; Gym Shorts or any other Gym attire.
- Overalls; cut-offs; clothes with frayed edges or holes
- Swimsuits or Swimwear of any kind; wet or soiled clothing
- Trousers, or other types of clothing that clearly are extreme in size and that cause the clothing item to hang loosely from the body, or that may expose areas of the body or visible undergarments, are prohibited.
- Tops exposing the mid-sections or other areas of the body are not acceptable.

Exceptions to the dress code will be: Attire worn for <u>Theme</u> <u>Parties</u> and other designated events which the general Manager must approve prior to the events.

Wearing appropriate blue denim will be permitted on the golf course although not encouraged, from November 1 through March 31.

Other Restrictions to: Bar, Dining Room, and Banquet Rooms

- Hats/caps for gentlemen are not permitted in the dining room except as traditional religious, ethnic, or medical head covering. Hats/caps must be worn facing forward. It is appropriate etiquette for gentlemen to remove hats while indoors.
- Shoes and/or sandals must be worn at all times.
- Soft spikes are not permitted in the Dining Room.
